6. Bank statement/ audit report/ other documents of the last 03 years showing turnover amounting to Rs.03 (m) per year.
7. The intending participants must be registered with PEC, for the year 2020-21 and relevant category.

9. The intending contractors should submit the affidavit to the effect whether he is not involved in any litigation and not abandoned the work in any government department and not black listed.
