INSTRUCTION:

- i. Single Stage-Two envelope Procedure will be adopted for the tender process. Bid shall comprise of a single package containing two separate envelopes. Each envelope shall contain separately sealed financial proposal and technical proposal. Envelopes shall be marked as **"FINANCIAL PROPOSAL"** and **"TECHNICAL PROPOSAL"** in bold and legible letters to avoid confusion.
- ii. Interested firms may obtain the tender document along with tender fees each Rs.2000/- each item for the supply of above Plant & Machinery and hardware equipments for Driving License Branches Sindh by submitting an application on their letter head alongwith tender fees from 08-02-2023 to 27-02-2023, till 1400 hrs on working days.
- iii. Sealed tenders on prescribed Performa in duplicate along with 2.5% Bid Security of the total bid in the form of Pay Order (Payee's A/c in favor of DIGP Traffic (L&T) Sindh Karachi, should be dropped in the tender box kept in office of the DIGP Traffic (L&T) Sindh Karachi, 11th Zamzama Street (Adjacent DL Branch) Clifton, Karachi, on or before 27-02-2023 at 1400 hours.
- iv. Samples of quoted item should be dropped with sealed tender covers at the time, date & address mentioned as S.No.3.
- v. The tender will be opened on 27-02-2023 at 1500 hours in presence of Procurement Committee and in presence of representative of bidders who choose to be present on the occasion, in the Committee Room of DIGP Traffic (L&T) Sindh Karachi office.
- vi. Suppliers & Firms registered with FBR for Sales Tax, Income Tax & other related taxes are eligible to participate in the tenders (documentary proof required).
- vii. Only bids offered on the prescribed tender form issued by the Police Department shall be accepted. However, additional sheets may be attached, if required.
- viii. Bidders must submit their bid/bids alongwith sample. Without samples bids will not be entertained.
- ix. Conditional tender / application will not be entertained.
- x. Police Department reserves the right to increase or decrease the quantity of items as per SPPRA Rules.
- xi. Competent authority can cancel the bidding process at any time prior to the acceptance of proposal as per provision of Rule-25(1) of SPP-Rules-2010 (Ammended-2019).
