Like wise corrections / over writing were found in the bid documents of M/S Salafah & Alizah in total amount of part "A" & total amount of all parts after amended in part A.


Signatures were received by both bidders on all the corrections/ over writing, as required by the SPPRA/ rules 2010 (amended 2019).


06. All the bid documents which were opened before committee on 30-03-2020 were also signed by the committee members as a token of authentication.


07. Concerned office is directed to process further in accordance with SPPRA Rules 2010 amended 2019 and also finalize them within one day positively.


