02/- On restoration to his original rank of Inspector he is posted to Crime Branch Sindh Karachi, with immediate effect.

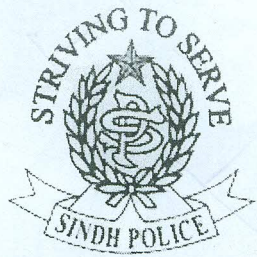
