NOTIFICATION

No. _____. In exercise of the power conferred by section 12 of Police Act, 1861 (Act No. V of 1861), the Inspector General of Police, Sindh, (with the approval of Government of Sindh), is pleased to make the following rules namely:

1. **Short title application and commencement:-** 1.1 These rules may be called "Sindh Police (Posting, Transfer & Tenure) Rules, 2017".

1.2. These rules shall apply to every person who is a member of the Sindh Police.

1.3. These rules shall come into force at once.

2. **Definitions:-** 2.1. For the purpose of the rules, unless there is anything repugnant in the subject or context,

(a) "Act" means The Police Act, 1861.

(b) "Assessment Board" means Board constituted and notified by the I.G.P., Sindh.

(c) "Command Post" means the post defined in Rules 4 and Table 1 of these rules containing specific period of posting under the rules.

(d) "Competent Authority" means Inspector General of Police, Sindh.

(e) "CPO" means Central Police Office.

(f) "Exigencies of service" means an urgent or unforeseen situation which immediately needs placement of an officer to a particular post or station in the



public interest, or in the interest of the police force, or to meet the demands of the situation.

- (g) “**Inspector General of police**” means Inspector General of Police, Sindh.
- (h) “**K.P.I.**” means Key Performance Indicator.
- (i) “**PER**” means Performance Evaluation Report by Supervisory Officers.
- (j) “**Regular Police**” means the member of Sindh Police who is in Executive Cadre of Sindh Police, excluding the members of Sindh employed in the Technical, Prosecution, Ministerial, Information Technology or any Cadre of Sindh Police, whether in uniform or not.
- (k) “**Staff Post**” means all posts other than the Command Posts.
- (l) “**Zone**” means one or more districts within any Range notified by Government of Sindh and headed by an officer not below the rank of Deputy Inspector General.

2.2. Any term or expression used but not defined in these rules shall have the same meaning as is assigned to it either in the Police Act, 1861, or in Police Rules, 1934.

3. **Powers of posting and transfer:-** In pursuance of powers conferred by Section 4, read with Section 12 of Police Act, 1861 (the Act), Inspector General of Police shall have the authority to order transfer and to post any Police Officer at any level, notwithstanding the tenure, serving in Sindh Police (inclusive of officers belonging to Police Service of Pakistan), in his discretion, and may exercise such powers either by himself or delegate any of these powers to his subordinate Police Officer under these rules.

4. **Command Post:-** 4.1. In terms of these rules, posts mentioned in Table 1 are declared as “Command Posts”.

4.2. Subject to rule 3, the officers posted against Command Posts shall not ordinarily be transferred from the post unless they complete their tenure assigned under Table. 1.

4.3. Pre-mature transfer of the officer posted against the Command Post shall be made in accordance with the procedure laid down under the rules.
