I am directed to refer to the subject noted above and to state that it has been observed that Civil Servants are frequently getting treatment of themselves and their dependents at Private Hospitals for the diseases which can be treated / are being routinely managed at public sector hospitals, at large, without emergency and genuine reason and subsequently submit their bills to the Govt. for re-imbursement, causing extra burden on the Govt's exchequer.

You are, therefore, requested to direct your sub-ordinate offices that henceforth, the employee (s) should approach initially to the concerned Services Hospital or any public sector of hospital for treatment purpose and if there is no facility of management of any disease they may be referred to tertiary care public sector hospitals viz Civil Hospital, Karachi, Jinnah Post Graduate Medical Center, Karachi, National Institute of Cardio Vascular Diseases Karachi, National Institute of Child Health Karachi, Chandka Medical College, Hospital, Larkana, Ghulam Muhammad Mahar Medical College Hospital, Sukkur, Peoples Medical College Hospital, Shaheed Benazirabad, Liaquat University Hospital, Hyderabad, Anwar Parachá Hospital, Sukkur, Lyari General Hospital, Karachi, Skin Hospital, Karachi, Sir C.J Institute of Psychotic, Hyderabad, Institute of Chest Diseases, Kotri, Ojha Institute of chest Diseases, Karachi, Spencer Eye Hospital, Karachi, Karachi Institute of Radiotherapy and Nuclear Medicine (KIRAN- FOR Benazirabad, Liaquat University Hospital, Hyderabad, Anwar Parachá CANCER PATIENT), Larkana Institute of Nuclear Medicine and Radiotherapy(LINAR) Nuclear Institute of Medicine and Radiotherapy(NIMRA) etc with referral letter of the secondary care level hospital (or any public sector hospital).

Then, the said referral letter may be signed by the assignee doctor and countersigned by the Medical Superintendent of the nearby hospital.
