**TENDER REQUIRED FROM REGISTERED AUCTIONEER FOR CONDUCTING AUCTION OF  
SINDH POLICE CONDEMNED VEHICLES/MOTORCYCLES & SCRAP ETC FOR THE YEAR-2019**

1. Sealed bids/tender are invited in accordance with Sindh Public Procurement Rules (Amended 2017) from Government approved/registered auctioneer to carry out auction of condemned vehicles, motorcycles, condemned tyres/tubes, batteries and other scrap etc of Sindh Police.
2. Interested firm should be registered with FBR & Sindh Revenue Board.
3. **Single stage one envelop procedure will be adopted.**
4. Bidding documents can be obtained from the office of the **Assistant Inspector General of Police, Motor Transport Sindh, Police Headquarter South, Garden Karachi** after paying tender documents fee of **Rs.1,000/- each** (non-refundable) from date of publication till 30<sup>th</sup> May 2019 at 1100 hrs. Copy of following documents will be required essentially while obtaining tender documents:
  - a.) Authority letter of applicant
  - b.) Copy of CNIC of applicant
  - c.) Copy of certificate/NOC as Government approved/registered auctioneer
  - d.) Copy of valid NTN Certificate of interested firm
  - e.) Copy of valid SRB Certificate of interested firm
  - f.) Work orders showing relevant experience for last three years (at least one each)
  - g.) Documentary evidence showing turnover at least last three years
  - h.) Affidavit that the firm is not black listed and involved in any litigation with Government of Sindh
5. The **BID** should be valid for the year 2019.
6. Firms offering their bids will provide **2% Bid Security** in shape of pay order in favor of Inspector General of Police, Sindh Karachi. The Bid Security of unsuccessful bidders is refundable once contract has been signed with successful bidder or the validity period has expired. Bid Security should be valid for a period of 28 days beyond validity period for bids i.e. 28<sup>th</sup> January 2020.
7. The successful firm will submit **Performance Security @ 5%** of in shape of pay order, demand draft or bank guarantee valid at least 90 days beyond completion of contract i.e. 31<sup>st</sup> March 2020.
8. Bids/tender should be reached in the office of the **Deputy Inspector General of Police, Technical & Transport Sindh, 4<sup>th</sup> Floor Central Police Office, I.I. Chundrigar Road Karachi** by 30<sup>th</sup> May 2019 at 1430 hrs., via registered post or by hand along with the earnest money.
9. Bids/tender will be opened **SAME DAY** i.e. 30<sup>th</sup> May 2019 at 1500 hrs., in the office of **Deputy**

**Inspector General of Police, Technical & Transport Sindh, 4<sup>th</sup> Floor Central Police Office, I.I. Chundrigar Road Karachi** before Auction Committee in presence of representatives of participating bidders.

10. Only bids offered on the prescribed tender form issued by procuring agency will be accepted.
11. Conditional bid/tender will be rejected.
12. The procuring agency reserves the rights to cancel the bidding process at any time prior to the acceptance of a bid or proposal.
13. Representatives of all participating bidders should sign attendance sheet on bid/tender opening date i.e. 30<sup>th</sup> May 2019.
14. Any/all bid submitted after the time prescribed as well as those not opened and read out at bid opening, due to any procedural flaw, shall not be considered and shall be returned without being opened.
