2. Single Stage One Envelops procedure will be followed. Bids in sealed envelopes should be submitted / dropped in the tender box kept in office of the Commandant Special Security Unit (SSU) near Hassan Square Karachi up-to 06-05-2019 till 1200 hours. The Bid shall be opened on the same day i.e. (06-05-2019) at 1230 hours at the same venue in the presence of Procurement Committee and intending bidders who choose to be present on the occasion.
3. Any other information relating to this tender/bid or detail of work or any further clarification can be obtained from the office of the Commandant, SSU near Hassan Square, Sindh Karachi at given address during office hours before opening of tender.
4. The Contractors/Contracting Firms are advised in their own interest to fully understand the scope of work and quality/quantities. They may also visit the site to asses themselves any additional/incidental work (availability of electricity, water or any other item) which may come up before or during execution of the work of this tender for the reason that no extra cost will borne out by Police Department for such eventualities nor any extension in time will be provided on such pretext.
5. The work will commence after the approval of the committee constituted by the competent authority and also subject to availability of funds which is in pipe line.

4. Only bids offered on the prescribed Tender Form issued by this department shall be accepted. However, additional sheets may be attached, if required. Conditional tender / application will not be entertained.
