In accordance with the Sindh Public Procurement Rules-2010 sealed bids are required from experienced private company / firm already registered in GST / Sindh Revenue Board and Labour Department Govt of Sindh for provision of labour (loaders) for specific job (load/unload) for lifting/towing of vehicles system of Karachi traffic police for a period of 12 months.

TERMS AND CONDITIONS OF THE TENDER:

- (VII) **SINGLE STAGE - ONE ENVELOPE** procedure will be adopted as per Rule-46(1). Envelopes shall be marked as "**BID FOR PROVISION OF LABOUR**" in bold and legible letters to avoid confusion.
- (VIII) Interested company / firm may obtain the bid documents from General Branch of Traffic Range Office, Police Headquarter, Garden Agha Khan 3rd Road Karachi by submitting an application on their letterhead and with the fee @ Rs.2000/- in the form of Pay order /Demand Draft in favour of DIGP Traffic Karachi from 28.10.2019 to 14.11.2019 up to 1400 hours.
- (IX) The last date of submission of bids along with Bid Security @ 2% of Bid price is 14-11-2019 upto 1430 hours and the Bids shall be opened on the same date at 1500 hours in the office of DIGP/Traffic Karachi in presence of bidders/representatives of the firms by the committee. The conditional bids will not be entertained.
- (X) The procuring agency may accept/reject the tender subject to relevant provision of SPPRA Rules.
- (XI) Only bids offered on the prescribed form issued by the Police Department shall be accepted. However, additional sheets may be attached, if required.
- (XII) Bidders are required to quote their charges in local currency (Pakistani Rupee) against the towing of one Car/jeep & one Motor Cycle separately.
