Sealed tenders on prescribed Performa in duplicate along with 2% earnest money of the total bid in the Shape of Pay Order (Payee's A/c in favor of DIGP/South Zone, Near Police Station Artilary Maidan Karachi should be dropped in the tender box kept in the office of the DIGP/South Zone, Near Police Station Artillery Maidan Karachi 21 .01.2021 at 1400 hours.
04. The tenders shall be open on 21.01.2021 at 1430 hours I presence of Procurement Committee and in presence of representatives of bidders who choose to be present on the occasion in the Committee in the office of the DIGP/South Zone, Near Police Station Artillery Maidan Karachi.
05. Only Suppliers /Firms registered with Income Tax Department GST & other related taxes are eligible to participate in the tenders (Documentary proof required).
06. All items should be best quality wise and samples may also be provided.
