The last date of submission of bids is 15.12.2021 at 10:00 hrs. The bid shall be opened on the same day at 1300 hrs in the office of the Principal RTC Khairpur in presence of interested bidders.
2. The interested bidders will deposit RS: 50,000/- for canteen and Regimental shop Rs:50,000/- and (Refundable) as security deposit via pay order in favour of Principal RTC Khairpur
3. Contractor Canteen shop will provide good / fresh quality items to all member of the staff and trainees on competitive rates. The rate list must be displayed on shop's wall /Board clearly. Expired items will not be allowed for sell at the canteen premises.
4. Special measures would be taken for the security of the centre. No other staff of canteen expect security cleared staff will be allowed to enter in the centre premises and their character certificate must be obtained from concerned District SsP. Monthly security pass issued by security section must be displayed by all staff inside in the centre premises.
5. The Shopkeeper / contractor will not give the shop to any other shopkeeper on rent.
6. The shop will not be damaged, encroached upon, or changed without prior approval of the competent authority.
7. Contractor will be responsible for the cleanliness & tidiness of the canteen shop & its surrounding premises.
8. Gutka, Pan, Naswar, liquor and other banned items will not be sold at the canteen.
9. The Timings of the Canteen shop will be from 0600hrs to 2200 hrs.
10. In case of any activity against the law /discipline brought in notice a strict departmental /legal action will be taken against the Contractor and agreement would be cancelled.
11. No, A/C / Heater will be installed in the shop, if the contractor fails to deposit monthly rent for the period of three months, his shop will be sealed and agreement cancelled.

13. The approved contractor will deposit monthly will by date of 10th of each month in shape of cheque or pay order to Commandant office.
