
TERMS & CONDITIONS.

4. Agencies/ firms should be registered with Sindh Revenue board and income tax authorities.
5. The agency/ contractor should have completed at least 03 nos. work of similar nature in last 03 years.
6. Bank statement/ audit report/ other documents of the last 03 years showing turnover amounting to Rs.03 (m) per year.
