1. Contractors/Contracting Firms are advised to quote rates on schedule of rates 2012 Sindh Government on percentage rate, above / below.
2. Payments shall be made for the works on basis of job, unit basis as the case may be on completion of each item/service, on the basis of measurement & verification in accordance with specification/Schedule "B".
3. The contractors/contracting firms will be required to show evidence of experience, capability in respect of personnel, financial position etc (Profile of the Firm, Technical Evaluation).
