Each envelope shall contain separately sealed FINANCIAL PROPOSAL and TECHNICAL PROPOSAL. Envelope shall be marked as "Financial Proposal and Technical Proposal" in bold and legible letters to avoid confusion.
02. Interested suppliers / firms may obtain the tender document along with tender fees Rs. 500/- each item for the supply of above item from the office of the DIGP/South Zone, Karachi near PS Artillery Maidan Karachi by submitting an application on their letter head along with tender fees from 19.03.2021 to 06.04.2021 during office hours on working days.

Sealed tenders on prescribed Performa in duplicate along with 2% earnest money of the total bid in the Shape of Pay Order (Payee's A/c in favor of DIGP/South Zone, should be dropped in the tender box kept in the office of the DIGP/South Zone, Near Police Station Artillery Maidan Karachi on 06-04-2021 at 14:00 hours.
04. The tenders shall be open on 06-04-2021 at 14:30hours in presence of Procurement Committee and in presence of representatives of bidders who choose to be present on the occasion, in the Committee Room in the office of the DIGP/South Zone, Near Police Station Artillery Maidan Karachi.
05. Only Suppliers /Firms registered with FBR for Sales Tax, Income Tax & other related taxes are eligible to participate in the tenders (Documentary proof required).
