TENDER FOR AUCTION

The contractors / bidders can participate in the said auction under the following terms and conditions:-

1. The highest contractor / bidder will produce stamp paper of Rs.100/- alongwith photocopies of his C.N.I.C as well as two witnesses for making an agreement.
2. Every participant will pay Rs.50000/- as security deposit in the shape of pay order or in cash which will be re-funded.
3. The highest bidder / contractor will pay 50% amount of bid as an advance per year.
4. 2nd Installment will pay 50% on 10th May season of the fruit of Mango Orchard.
5. The contractor may undertake to bear for any foreseen or unforeseen loss.
6. The contractor will bear all expenditures of transportation, labor and other related expenses incurred during the execution of the contract.
7. The contractor will be liable for any damage caused to the property of persons by him or any of his employees of workers.
8. Special arrangements will be taken for the security of the Center. No other staff of the contractor except security cleared staff will be allowed to enter in the Center premises and their character certificate must be obtained from the concerned District SSsP.
