

Each envelope shall contain separately sealed financial proposal and technical proposal. Envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion.
2. Interested firms may obtain the tender document along with tender fees Rs.2000/- each item for the supply of above equipment from the office of the Project Director Information Technology ground floor Central Police Office, I.I. Chundrigar Road, Karachi by submitting an application on their letter head alongwith tender fees from **10-03-2022 to 25-03-2022 @1400 hours**.
3. Sealed tenders on prescribed proforma in duplicate along with 2.5% earnest money of the total bid in the form of Pay Order (Payee's A/c in favour of IGP Sindh) should be dropped in the tender box kept in office of Project Director Information Technology ground floor Central Police Office, I.I. Chundrigar Road, Karachi **on or before 25-03-2022 at 1400 hours**.
4. The tender shall be opened **on 25-03-2022 at 1430** hours in presence of Procurement Committee and in presence of representatives of bidders who choose to be present on the occasion, in the office of DIGP I.T Central Police Office, Sindh, I.I.Chundrigar Road, Karachi.
5. Only authorized dealers/distributors and suppliers registered with FBR for Sales Tax, Income Tax & other related Taxes are eligible to participate in the tenders (documentary proof required).
6. Only bids offered on the prescribed tender form issued by the Police Department shall be accepted. However, additional sheets may be attached, if required.
7. Bidders should submit their bid/bids alongwith samples except item no. 12. Without samples bids will not be entertained.
