Contractor/Contracting firms should be registered with Pakistan Engineering Council (Applicable on above 4 Million), FBR Sales Tax, Income Tax (N.T.N & S.T.N Active) and Sindh Revenue Board (SRB registration certificate must required) and Bank Statement for the last 3 years showing annual financial turnover amounting to Rs.10-Million per year are eligible to participate in the tender (Documentary proof required).

- Contractor/Contracting firms are advised to quote rates on scheduled of rates 2012 (amendment in 2019) Sindh Government on percentage rate, above below.
- Payment shall be made for the works on basis of job, unit basis as the case may be on completion of each item/service, on the basis of measurement & verification in accordance with **specification/Schedule "B"**.
- Contractors/contracting firm will be required to show evidence of experience, capability in respect of personnel, financial position i.e (**Profile of the Firm, technical Evaluation, Work order, Work Compellation etc**).
- Contractors/contracting firms blacklisted by Government Department or agencies will not be allowed to participate in the tender /bid (Participating contractor should submit an affidavit to the effect that he is not involved in any litigation with any procuring agency and has not abandoned the work in any government department and has not been black listed by any procuring agency) for any Government Department. Contractors will be required to provide copy of CNIC and contracting firms will also be required to provide certificate of registration (Category wise).
- Only bid offered on the prescribed Tender Form issued by this department shall be accepted. However, additional sheet may be accepted, if required. Conditional, Incomplete, Blank electronic & telegraphic tender / application will not be entertained.
- Validity of bid / offer shall be at least **90-days** from the date of opening of tender.
- Work order shall be issued after release of fund from Finance Department Government of Sindh.
- The Competent authority reserves the right to reject all or any tender/bid subject to and in accordance with the relevant provisions of the rule-25 (1) of SPP-Rules.2010 (Amended 2019) and conditions contained in Tender/ Documents.

## **INFORMATION & PROCEDURE:**

1. Single Stage-One Envelop Procedure will be adopted for the tender process. Bid shall comprise one single envelope containing the financial proposal and required information.
2. Interested firms may obtain the tender form alongwith tender documents for the above work from the office of the DIGP East Zone **General Branch** Karachi by submitting an application on their letter head along-with tender fees (Cash non refundable) from **03-01-2022** to **19-01-2022**, during office hours.
3. Tenders/Bids on prescribed proforma along-with pay order (Payee's A/c in favor of **Deputy Inspector General of Police East Zone Karachi**) shall be dropped in tender box (placed in the office of **DIGP East Zone Office Conference Room, Karachi**) on **20-01-2022, at 1400hrs**. The tender will be opened by Procurement Committee on the same date at **1430hrs** in presence of authorized representative of bidders participating in the tender/bid.
4. The Contractors/Contracting firms are advised in their own interest to fully understand the scope of work and quality /quantities. They may also be visit the site to assess themselves any additional / incidental work (availability of electricity, water or any other item) which may come up before or during execution of the service of this tender for the reason that no extra cost will borne out by Police Department for such eventualities nor any extension in time will be provided on such pretext.
