4. **Agencies/Firms should be registered with Sindh Revenue Board and Income Tax authorities and Pakistan Engineering Council for more than 4.00 million works.**
5. The agency/contractor should have completed at least 03 numbers of works with documentary proof related to civil works that shows repair or construction of building works. This condition is applicable for all participants that are willing to participate in tender having amount 2.00 Million or more than 2.00 Million.
6. Bank statement of the last three years showing annual financial turnover.
7. The competent authority reserves the right to reject any or all tenders according SPPRA Rules 2010 (Amended 2019).
8. Every intending contractor should submit an affidavit to the effect that he is not involved in any litigation with any Procuring Agency and has not abandoned the work in any Government Department and has not been black listed by any Procuring Agency.
