Envelope shall be marked as Financial Proposal and Technical Proposal in bold and legible letters to avoid confusion.

Interested suppliers / firms may obtain the tender documents along with tender fees Rs.500/- each items for the supply of above items from office of the DIGP/South Zone, Karachi Near Police Station Artillary Maidan Karachi by submitting an application on their letter head along with tender fees from the date of publication of the tender upto 21.09.2021 to 07.10.2021 during office hours on working days.
