TERMS & CONDITIONS

- Blank tenders will be issued to the agencies/Firms on the payment of tender fees mentioned against each work. (non-refundable) alongwith an application on company's letter head with three work orders related to maintenance & repair works in same year or previous three years, PEC, CNIC, SRB & NTN certificates updated copies. Tender documents will not be issued without above mentioned requirements.
- Conditional / blank / incomplete and not accompanied with call deposit, bids will not be considered.
- The bidders properly fill Schedule Book Documents including schedule and non scheduled items also write amount of difference of material, carriage of material and premium as per rules. It is strictly observe that bid quoted amount should not exceed the tender amount.
- If the competent authority remains out of Head Quarter on the date of opening of the tenders, or any holiday is announced by Government, then tenders will be received & opened on the next working day on same schedule & place.
- Agencies/Firms should be registered with Sindh Revenue Board and Income Tax authorities and Pakistan Engineering Council for more than 4.00 million works.
