

3/- Single Stage One Envelops procedure will be followed. Bids in sealed envelopes should be submitted / dropped in the tender box kept in office of Muhafiz Force / Madadgar-15 near Hassan Square, Aziz Bhatti Police Station, Karachi up-to 18-10-2023 till 1500 hours. The Bid shall be opened on the same day i.e. 18-10-2023 till 1530 hours at the same venue in the presence of Procurement Committee and intending bidders who choose to be present on the occasion. In case of Public holiday announced by the Government, bids will be opened on very next working day.
