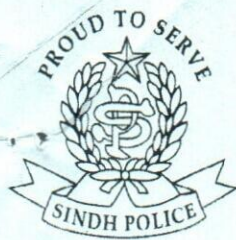

Interested firms may obtain the tender document along with tender fees each Rs.2000/- each item for the supply of above Others non recurring /recurring items /Marketing equipments for Driving License Branches Sindh by submitting an application on their letter head alongwith tender fees from 13-03-2023 to 29-03-2023, till 1030 hrs on working days from office of the DIGP Traffic (L&T) Sindh Karachi, 11th Zamzama Street (Adjacent DL Branch) Clifton, Karachi.
- iii. Sealed tenders on prescribed Performa in duplicate along with 2.5% Bid Security of the total bid in the form of Pay Order (Payee's A/c in favor of DIGP Traffic (L&T) Sindh Karachi, should be dropped in the tender box kept in office of the DIGP Traffic (L&T) Sindh Karachi, 11th Zamzama Street (Adjacent DL Branch) Clifton, Karachi, on or before 29-03-2023 at 1100 hours.
