

2/- Complete terms & conditions and list of required items in the above mentioned heads are available in tender documents, which can be purchased from the office of the Commandant Special Security Unit (SSU) near Hassan Square Karachi from 13-12-2022 to 03-01-2023 during office hours by submitting an application on their letter head along with tender fees Rs. 1,500/- (non-refundable). These documents can also be downloaded from the Sindh Police website (www.sindhpolice.gov.pk) and SPPRA website (www.pprasindh.gov.pk).

3/- The bidding firm should clearly indicate its Bank Account, NTN, GST and AG Sindh Vendor numbers in the Tender/Bid otherwise, it will be rejected. The proof of Income Tax Registration and GST numbers should also be enclosed with the tenders.

4/- The bidding firms are required to attach a list of offices / organizations to whom they have supplied similar items, with a copy of supply orders.

5/- The bidding firms should have their proper Business Centre with telephone & fax numbers in Sindh/Karachi.

6/- The Procurement procedure Single Stage Two Envelops will be followed. Bids in sealed envelopes should be submitted / dropped in the tender box kept in office of the Commandant Special Security Unit (SSU) near Hassan Square Karachi up-to 03-01-2023 till 1500 hours. Bid shall comprise of a single package containing two separate envelopes. Each envelope shall contain separately sealed

technical proposal and financial proposal. Envelopes shall be marked as "TECHNICAL PROPOSAL" AND FINANCIALPROPOSAL" in bold and legible letters to avoid confusion. The Bid shall be opened on the same day i.e. 03-01-2023 at 1530 hours at the same venue in the presence of Procurement Committee and Bidders intending to attend the meeting. In case of Public holiday announced by the Government, bids will be opened on very next working day.


7/- Bid Security 2% of the total bid in the form of Pay Order in favor of the AIGP / Security Karachi should be submitted with Financial Bids. Interesting Bidder must submit Company profile, three years Annual turnover, Experience / Previous three work orders and Affidavit that firm is not black list and involved in litigation.

8/- Only bids offered on the prescribed tender form issued by the Procuring Agency shall be accepted. However, additional sheets may be attached, if required. Only head-wise Comprehensive bids will be accepted. The Procuring Agency may reject any or all bids or postpone date as per relevant provisions of SPPRA Rules, 2010.

9/- Keeping in view the budget position, quantity of items can be increased / decreased in the line with provision of SPPRA rule. All prices should be inclusive of all taxes, etc.
