TERMS & CONDITIONS

1. Single stage one envelope procedure will be adopted for the tender process. Each bid shall comprise one single envelope containing the financial proposal and required information mentioned in Evaluation Criteria of bidding documents.
2. Interested suppliers / firms may obtain the tender document for the supply of Dietary Food items for the trainees Mess of PTC Shahdadpur by submitting an application on their letterhead along with tender fee of **Rs.3000/-** from **15.08.2023 to 30.08.2023**.
3. Sealed tenders on prescribed proforma in duplicated along with 2% earnest money of the total bid in the form of Pay Order (Payee's A/C) in favour of Principal, PTC Shahdadpur should be dropped in the Tender Box kept in the office of the Principal Police Training College Shahdadpur on **30.08.2023 at 1300 hours**.
4. The tender shall be opened on **30.08.2023 at 1330 hrs** in the presence of Procurement Committee and representatives of bidders who choose to be present on the occasion in the office of the Principal PTC Shahdadpur.
5. Only suppliers firms registered with FBR for Sales Tax & SRB Income Tax, other related taxes are eligible to participate in the tender (Documentary proof required).
6. All items should be hygienic and quality-wise samples may also be provided.
7. Only bid offered on the prescribed tender form issued by the Police Department will be accepted. However, additional sheets may be attached, if required.
8. Conditional tenders / applications will not be entertained.
9. Competent Authority can cancel the bidding process at any time prior to the acceptance of proposal as per provision of Rule-25(1) of SPPRA Rules-2010 (Amended-2019).
