
2. The agenda of the meeting was to open the proposals / offers of bidders. The bid was opened in-front of all bidders, in the light of SPPRA Rules.


04. Keeping in view of the above the procurement committee unanimously decided that due to incomplete / expired documents, the tender process may be cancelled and new tender may be issued accordingly.


