

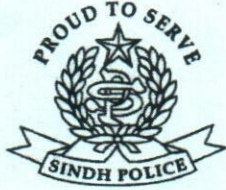

Envelopes shall be marked as "**FINANCIAL PROPOSAL**" and "**TECHNICAL PROPOSAL**" in bold and legible letters to avoid confusion. Sealed tenders on prescribed Performa in duplicate along with 2.5% Bid Security of the total bid in the form of Pay Order (Payee's A/c in favor of DIGP Traffic (L&T) Sindh Karachi, should be dropped in the tender box kept in office of the DIGP Traffic (L&T) Sindh Karachi, 11th Zamzama Street (Adjacent DL Branch) Clifton, Karachi, on or before 02-05-2023 at 1430 hours.
- iv. The tender will be opened on 02-05-2023 at 1500 hours in presence of Procurement Committee and in presence of representative of bidders who choose to be present on the occasion, in the Committee Room of DIGP Traffic (L&T) Sindh Karachi office.
