3. Payment shall be made for the works on basis of job, unit basis (as the case may be) on completion for each item/work, based on measurement & verification in accordance with specification/schedule "B".
4. The work calculation/REC may vary by (+) or (-) 5%.
5. Contractors/firms will be required to show evidence of experience, capability in respect of personnel/machinery, financial position etc., (profile of the firm).
