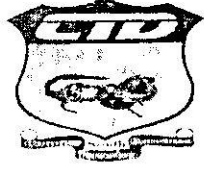

2. Least cost selection method.

4. Bidder should provide a security clearance certificate from Home Department Sindh.
5. Consultants firms, blacklisted by Government Departments, are not be allowed to participate in the Tender. Bid Bidders are required to submit an affidavit to the effect that they are not blacklisted from any Government Department.
6. Bids offered on the prescribed tender Form issued by this department/download from SPPRA Website shall be accepted. However, additional sheets may be attached, if required.
