1. Single Stage Two Envelops Procedure will be adopted for the tender process. Bid shall comprise of a single package containing two separate envelopes. Envelopes shall be marked as " FINANCIAL PROPOSAL" and TECHNICAL PROPOSAL" in bold and Legible letters to avoid confusion.
2. Interested supplier, Authorized dealers & well reputed firms may obtain the tender document along with tender fees, item for the supply of above Heads from the office of the Medical Superintendent Regional Police Hospital Hyderabad by submitting an application on their letter head along with tender fees from date of publication in newspapers up to 13-09-2023 at 12:00 PM.

4. The tender Shall be opened on 13-09-2023 at 01:00 PM in presence of Procurement committee in presence of representative of bidders who choose to be present on the occasion, in the Office of the Medical Superintendent Regional Police Hospital Hyderabad.
