1. Interested Suppliers / Firms may obtain the Bid / Tender documents for the supply of Dietary Food Items for the trainees from Accounts Office PTS, Larkana by submitting an application on their letter head.
2. Blank tenders will be issued to the interested Suppliers / Firms on the payment of tender fees of Rs. 1000/- (non refundable) from 22.03.2023 to 10.04.2023 @ 1200 hrs.
3. Sealed tenders on prescribed Performa in duplicate along-with 2% earnest money of the total bid in the form of Pay order (Payee's A/C in favour of Principal Police Training School, Larkana should be dropped in the tender box kept in the office of the Principal Police Training School, Larkana till 10.04.2023 @ 1400 hrs.
4. Only bid offered on the prescribed tender form issued by the Police Department will be accepted. However, additional sheets may be attached, (if required).
5. Incomplete, blank, & Conditional bids will not be entertained and will be rejected.
6. Single stage one envelope Procedure will be adopted for the tender process. Each bid shall comprise one single envelope containing the financial proposal and required information mentioned in Evaluation Criteria of Bidding Documents.
7. The tender will be opened on the same day / date 10.04.2023 at 1500 hrs PM in presence of Procurement Committee and in presence of Bidders / Representatives of bidders who choose to be present on the occasion in the office of the Principal Police Training School, Larkana.
8. If the SSP / Principal Police Training School, Larkana remain out of headquarters or Government announces a public holiday on the opening date of Bid / Tender will be received back next working day up-to 1400 hrs PM and will be opened @ 1500 hrs.
9. Only Suppliers / Firms registered with FBR for Sales Tax, & SRB Income Tax other related taxes are eligible to participate in the tenders (Documentary proof required)
