ORDER

In compliance of orders passed by the honorable High Court Sindh in C.P. NOs. 4280/2019, 4092/2016 and 5109/2016, the following candidates were appeared in interview and declared successful by the Recruitment Committee. Consequent upon the recommendations of the Recruitment Committee and approval of Inspector General of Police Sindh, the following Candidates who have been declared medically fit by the Medical Superintendent Police Hospital, Karachi are hereby appointed as Police Commando (Constable BPS-05) viz (10260-500-25260) in Sindh Police against the existing vacancies of Special Security Unit (SSU) with immediate effect :-

02. They will draw pay from SSU against existing vacancies. However, their seniority shall be maintained in respective district of Domicile as per Police Rules, 1934.

03. Their appointment is subject to the following conditions/codal formalities :

- i. The appointment shall be purely on temporary basis and to be confirmed on completion of successful probation period of three years.
- ii. The appointment shall be governed by Police Act 1861, Police Rules 1934 and all other existing laws, Rules and any other laws/rules framed as such.
- iii. They will undergo Recruit Training Course as provided under Chapters 12 & 19 of Police Rule 1934 and other special training programmes devised by the Training Branch CPO from time to time.
- iv. Verification of having good character/antecedent from Local Police/CRO (I.T. Branch CPO) and Special Branch.
- v. In case of resignation from the post/service without giving two months notice in advance the personnel will have to deposit two months salary in the Government exchequer.

- vi. They will be governed under Police Act 1861 / Police Rule 1934 & the prescribed rules / policies of the Government / Competent Authority.
- vii. They will have to join the office of the Commandant SSU Sindh at Hassan Square Karachi for further duty within 15 days of issuance of the appointment order and uploading of the same on Sindh Police's Website positively. In case of non-reporting of an individual within the given time frame, this order shall stand cancelled in respect of such candidate and next one from merit list will be considered for appointment.
- viii. They will not be entitled to claim any TA / DA for the above purpose and joining duty.
- ix. Being a member of Police force they will have to serve any part of the province of Sindh as per orders of the superiors.
- x. The appointment shall be liable to be cancelled in case of any above condition is not fulfilled or any documents is found fake/forged at any stage.
