SUBJECT: RECOMMENDATIONS OF SPECIAL PROVINCIAL RECRUITMENT COMMITTEE (SPRC) FOR RECRUITMENT OF LEGAL HEIRS OF SHAHEED POLICE EMPLOYEES OF SINDH POLICE IN THE LIGHT OF RECRUITMENT RULES, 2021.

It is intimated that in pursuance of Recruitment Rules, 2021, Special Provincial Recruitment Committee (SPRC) was constituted to conduct recruitment in r/o legal heirs of Shaheed Employees of Sindh Police against the reserved posts in the Shaheed quota in a transparent manner as per directions of the Home Department, Government of Sindh.

2/- The Special Provincial Recruitment Committee (SPRC) has conducted the interview of those candidates who were declared pass in all requisite tests i.e (physical/endurance & written tests) by the PTS for the post of ASI & Sub-Committee-III for the posts of HC (Wireless Operator), PC/LPC, DPC & Class-IV Staff against Shaheed quota.

3/- SPRC has considered the successful candidates (case to case) as per following Terms of References (TORs):-

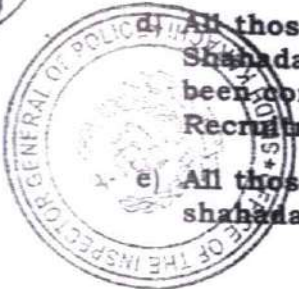
a) All those claimants who passed all requisite tests for the posts they applied have been interviewed in accordance with Recruitment Policy-2022.

b) As per Sindh Police Recruitment Policy-2022, Interview shall be of 50 Marks and minimum 50% (i.e. 25% marks) in r/o executive posts are required for qualifying the Interview.

c) All cases of claimants who appeared in interview for the post they applied have been finally scrutinized in the light of reports of scrutiny Committee-I & II and re-verification of reports furnished by respective Sub-Committee-II of Ranges in the light of Sindh Police (Shaheed, Deceased, and Permanently Invalidated or Incapacitated Quota) Recruitment Rules, 2021.

d) All those cases of claimants whose fathers/brothers or mothers embraced Shahadat before promulgation of Shaheed Act-2014 i.e 11.06.2014 have been considered for one claim of job against Shaheed quota in the light of Recruitment Rules, 2021.

e) All those cases of claimants whose fathers / brothers or mother embraced shahadat after promulgation of Shaheed Act-2014 11.06.2014 have been



considered for two claims of jobs against Shaheed quota in the light of Recruitment Rules, 2021.

- f) Cases of those claimants whose fathers / brothers or mothers' declarations could not be issued due to old martyrdom i.e before 2011 have been checked through the availability of grant of Shaheed Compensation awarded to the family of Shaheed in the record.
- g) Only those claimants whose fathers / brothers or mothers who died in Road Traffic Accidents (RTA) during the duty and have been declared as Shaheed by the Shaheed Declaration Committee and issued Declaration of Shaheed by the Welfare Branch, CPO have been considered for jobs accordingly in the light of Recruitment Rules, 2021.
- h) The legal heirs of Shaheed who possess domicile of other province are also considered and recommended for recruitment being legal heirs of Shaheed who embraced martyrdom in the line of duty while serving in Sindh Province.
- i) All requisite tests passed candidates have been considered only against availability of seats in quota.
- j) Case of Shaheed private security guard of Pakistan Stock Exchange for recruitment of his son is considered duly approved by provincial cabinet.

4/- After final scrutiny / re-verification of claims through Sub-Committee-II of respective Ranges and assigning interview marks by the Special Provincial Recruitment Committee (SPRC) as per Recruitment Policy-2022, the SPRC has recommended the following Legal Heirs for the posts of ASI, HC (Wireless Operator), PC, Lady PC, Driver PC & Class-IV (Naib Qasid) subject authentication of claims for job respectively:-
