**APPOINTMENT ORDER.**

3/. In case he resigns from the post without giving two months notice in advance, he will have to deposit salary of two (02) months in the Government Treasury.

4/. He will be governed by the Sindh Civil Servant Act 1973 and Rules / Polices framed there under time to time.

5/. His services can be utilized throughout Badin District.

6/. He shall not be entitled to change of cadre from Sanitary Worker to any other cadre.

7/. He will not be entitled to claim any TA/DA for joining duty.

8/. He will join his duty to SSP Office Badin, after issuance of this appointment order.

9/. In case, any of above condition is not fulfilled or submission of any fake statement or fake document is disclosed at any stage may entail cancellation of this appointment order and criminal liabilities against him.

10/. 15 years age relaxation shall be allowed to overage candidate vide Government of Sindh notification No:SOII/SGA&GD)5-64/20211 dated 23.11.2023.
