Khan Khero	District Larkana	<p>As per report of SSP/District Larkana (addressed to the DIGP/Larkana) vide letter dated 10.07.2020, the cases of (125) candidates of Larkana Range who fulfill the required criteria in accordance with Standing Order No.211/2007 &amp; Standing Order No.260/2011 were recommended for appointment by the Range Committee headed by the DIGP/Larkana Range held on 09.01.2013. Out of said 125 candidates of Larkana Range, 35 candidates belonged to District Larkana, in which the case of applicant Mansab Ali So Rtd: HC/518 M. Khan Khero was not recommended by the committee being not found eligible as per Standing Order.</p> <p>In pursuance of approval of CPO accorded vide letter No.3197-98/EB-III/T-7/S&amp;S, dated 05.03.2013, appointment orders in respect of (35) successful candidates of District Larkana were issued after fulfillment of codal formalities.</p> <p>Later-on, the applicant failed a C.P No.D-1103/204 in the Honorable High Court of Sindh, Circuit Court Larkana, which has been disposed off on 14.11.2018.</p>

03. The matter has been scrutinized and obtained reports from the respective Ranges / Units.


04. On the basis of reports, it has been observed that the matter pertains to Son Quota which does not exist in Sindh Police in view of the judgment passed by the Honorable Supreme Court of Pakistan in Civil Petitions No.493,494,505 to 508, 529 to 532,533,601,906 and 911 to 917 of 2015, whereby all the Standing Orders in Sindh Police were withdrawn.



5. Moreover, the Honorable High Court of Sindh, Circuit Court Hyderabad in an order passed on 31.10.2019 in C.P No.D-2671/2016 & others has also dismissed various petition regarding recruitment against Son quota in Sindh Police. The operative para of said order is reproduced as under:-

***"In the light of above discussion it is crystal clear that Police Department cannot circumvent the law to make appointment by using Standing Order. The appointment can only be made through competitive process on merit as provide under the Recruitment Rules and not otherwise. In view of what has been discussed above, the instant Constitution Petitions are dismissed alongwith pending application(s)."***

In the light of orders of the Apex Court state above, no claim shall be entertained from the Children of Serving & Retired Employees of Sindh Police.
