ORDER

In compliance of the orders dated 18.03.2020 and dated 19.10.2020 passed by the Honorable High Court of Sindh, Karachi in C.P No.D-6622 of 2019 filed by Javed Iqbal & others, the following Candidates / petitioners are hereby appointed as Police Constable (BPS-05) in Sindh Police against the existing vacancies of Sindh Reserve Police, with immediate effect on terms & conditions as mentioned below:-

- i. Appointment is made subject to outcome of the Leave to Appeal submitted by the Police Department bearing No.380-K/2020 before the Honorable Supreme Court of Pakistan.
- ii. They will draw pay from SRP against existing vacancies. However, their seniority shall be maintained in respective district of Domicile as per Police Rules, 1934.
- iii. Medical fitness certificate from M.S Police Hospital, Karachi.
- iv. Verification of having good character/antecedent from Local Police/CRO (I.T. Branch CPO) and Special Branch.
- v. Verification of CNIC, Domicile / RPC & educational documents from concerned authorities.
- vi. The appointment shall be purely on temporary basis and to be confirmed on completion of successful probation period of three years.
- vii. The appointment shall be governed under Repeal of Police Act, 1861 and revival of Police Order, 2002 (Amendment) Act 2019 and existing Law as well as Police Rules, all other relevant laws, Rules framed as such.
- viii. They will undergo Recruit Training Course as provided under Chapters 12 & 19 of Police Rule 1934 and other special training programmes devised by the Training Branch CPO from time to time.

- x. In case of resignation from the post/service without giving two months notice in advance they will have to deposit two months salary in the Government exchequer.
- x. They will have to join the office of the DIGP SRP at Qayyumabad Karachi for further duty within 15 days of issuance of the appointment order. In case of non-reporting within the given time frame, this order shall stand cancelled.
- xi. They will not be entitled to claim any TA / DA for the above purpose and joining duty.
- xii. Being a member of Police force, they will have to serve any part of the province of Sindh as per orders of the superiors.
- xiii. The appointment shall be liable to be cancelled in case of any above condition is not fulfilled or any documents is found fake/forged at any stage.
