NO.SOJI/8-1(04)/2020 (Stage-2 NPIs): In partial modification of this departments order of even number dated 23.11.2020 Government of Sindh in exercise of powers under section 3 (1) of Sindh Epidemic Diseases Act 2014 (Act VIII of 2015) is pleased to direct as under throughout the Province of Sindh:-

1. Businesses timings shall be Six days per week (with one day off on Friday or Sunday as applicable to that area concerned)
 2. Businesses / Markets timings 06:00 am to 08:00 pm.
 3. **Restaurants** – Only outdoor dining till **10:00** pm and takeaway / home delivery.
2. The orders shall come into force immediately and effective till 31st January, 2021 unless changed or amended earlier.
