Director Division Health Services Larkana, Akhtar Hussain Kourejo, DEO (Secondary), Larkana, Gul Sher Soomro, DEO (Primary), Larkana, Gul Bahar Magsi, Focal Person Litigation, D.S.E (Primary), Larkana, Abdul Aziz Chachar, Director (Secondary) Larkana & Manzoor Ali Dhamrah on behalf of Administrator, Municipal Corporation, Larkana are present.

In compliance of order dated: 06.12.2022, comments/progress reports have been filed by the respondents, which are taken on record, copies whereof have been provided to learned counsel for the petitioner.

2. Petitioner as pro bono public has maintained this petition on the various issues of District Larkana regarding mismanagement and ghost employees in different Departments, particularly in Education, Police. Health Departments and Local Government Department etc. On the last date of hearing, respondents were directed to file lists of their employees with details of their place of posting but they failed to provide list and only District Education Officer (Secondary), Larkana, had furnished his report by stating therein that about 200 Teachers are not performing their duties and he has issued show-cause notices to them. Today District Education Officers, Primary Secondary have filed lists of employees working in their department belong with supporting affidavits which are taken on record. Director, Education is also present and submits that they have issued show-

cause notices to 37 Teachers who are absent from their duties, therefore, he has issued Form-II to District Accounts Officer, in order to stop their salaries. At this juncture, D.C Larkana, is present and submits that Education & Literacy Department has formed monitoring system in order to ensure the attendance of the Teachers and other staff and at District level, Chief Monitoring Officer is responsible, whereas, Monitoring Officers are working at Taluka Level, who are assigned work to verify attendance of the Teachers and they are bound to submit their reports to Director General (Monitoring) at Province level. Zameer Hussain Khokhar, District Accounts Officer, Larkana, is also present in Court and submits that he can stop the salaries of ghost employee when he receive Form-II from concerned Officer/Department. However, he has pointed out that it is a long process which would usually take years to receive form-II. We have observed that in fact no effective vigilant monitoring system is available in Education & Literacy Department to verify the attendance of Teachers on their place of posting, therefore, we direct Director General, (Monitoring) Sindh to appear in person along with report for procuring attendance of the Teachers and process of issuance of Form-II.

3. Medical Superintendent, CMCH Larkana, also files list of employees working in his office along with supporting affidavit which is taken on record, he submits that about 200 employees have not verified their record, whereas, 18 doctors are absent from their duties to whom he has issued show-cause notices and issued Form-II to District Counts Officer to stop their salaries.

PDSP Larkana has also placed on record details of staff of various categories working in District Police Larkana along with supporting affidavit of SSP Larkana which is taken on record.

District Accounts Officer has also filed details of employees working in Education, Health and Police Department which is also taken on record.

Deputy Commissioner Larkana, who is also Administrator of Municipal Corporation Larkana has filed progress report which is also taken on record, he submits that he has proposed tentative master plan for Sewerage System for Larkana and prepared PC-1 and he will recommend PC-1, to the Secretary Public Health Engineering Department, Govt. of Sindh and Secretary, Planning & Development, Govt. of Sindh to include this project in Annual Development Program (A.D.P) for next budget of 2023-24. He further submits that they have also suggested oxidation plan in the project. He has also placed on record details of encroachment drive in Larkana, Naudero, Ratodero and other cities of Larkana District as well as progress report of Sindh Solid Waste Management, which is quite satisfactory. We also direct District Health Officer Larkana to file list of employees in his office against place of posting on next date of hearing.

7. Vice Chancellor, Registrar and Project Director, SMBBMU, Larkana are called absent. No intimation is received and even no progress reports have been submitted by them, which shows that they have no respect and honour for Court orders. Issue show-cause notice to V.C, Registrar and Project Director SMBBMU, Larkana for non compliance of Court directions. Further they are directed to provide the details of development budget received from H.E.C and Government of Sindh for last five years and its utilization. The report should be comprehensive.

After going through the progress reports and submissions made by the learned counsel for petitioner and Officers of Education & Literacy Department, Medical Superintendent, CMCH Larkana, PDSP

Larkana and Deputy Commissioner Larkana, following discetions access insued:

- Secretary, Education & Literacy Department to place (1) details of teaching as well as non-teaching staff on website with name of employee with parentage, his CNIC number and place of posting by mentioning Taluka & District.
 - IOP Sindh to place details of staff working under his (11) sub-ordination on website with name of employee, his CNIC number with parentage. He shall also submit the report for mechanism to ensure the attendance of working staff.
 - Secretary, Health Department, Govt. of Sindh to place details of staff working under his sub-ordination on website with name of employee, his CNIC number and with parentage.
 - Deputy Commissioner Larkana to forward sewerage plan for Larkana, to Secretary Public Health Engineering Department & Secretary, Planning & Development Department, Govt, of Sindh, to include this project in next fiscal year 2023-24. We also direct District Accounts officer, Larkana to tally the list of employees provided by District Education Officers, Primary & Secondary, Larkana and also list of employees furnished by SSP Larkana and Medical Superintendent, CMCH, Larkana.
