PERFORMANCE EVALUATION REPORTS /ANNUAL CONFIDENTIAL REPORT OF SINDH POLICE OFFICIALS

I am directed to convey the direction of IGP, Sindh for compliance in the light of Police Reforms Committee, regarding initiate PERs/ACRs. The following points in respect of Point no. 7 of the minutes of meeting received through letter No. 14902-29/AIGP/OPS-II/2022 dated 12-04-2022 (copies enclosed) may please be observed before writing of Performance Evaluation Reports / Annual Confidential Reports of Sindh Police Officials.

- i. The PERs/ACRs are the most important document in the career of a Government servant. An officer's promotion and retention in service mostly depends on what has been recorded in the PERs/ACRs. The preparation of Evaluation reports is an important and responsible duty. The manner in which Evaluation reports are written will be taken into account in judging the qualities of the reporting officer. The opinions which are expressed should represent the result of careful consideration objective assessment, so that, if called upon, the reporting officer could justify the assessment of his subordinate made by him.
- ii. It is a system of making judgment about Government servant of various levels by their superior in or to guide selection and other personnel decision. The character roll dossiers maintained for the purpose contains a systematically prepared and carefully assembled performance record of the official concerned.
- iii. The Government is responsible for issue of policy directions for preparation and maintenance of the confidential record of each government servants.
- iv. Many reporting officers are overly generous in their assessment. In some extreme cases, reporting officers have rated all officers serving with them as "very good" which is obviously a misjudgment.
- v. Such reporting places equally good officers of the same group working elsewhere at a disadvantage since their work is evaluated under more objective and stricter criteria.
- vi. Adverse remarks are often recorded by the reporting officers without prior counseling to the officer reported upon. This is contrary to the existing instructions and is, in fact, a reflection on the reporting officer. They are expected to counsel an officer about his weak points and advise him how to improve. Adverse remarks should normally be recorded only when the officer fails to improve despite counseling.

- vii. The countersigning officers, when differing with the assessment or remarks given by a reporting officer, neither score these out nor do they give their own assessment in red ink against the relevant remarks. These entries, particularly on "quality and output of work" and "integrity" are of crucial importance when considering an officer for promotion.
- viii. It is hoped that reporting and countersigning officers will avoid these deficiencies in reporting.
- ix. The Countersigning Officer should weigh the remarks of the RO against his personal knowledge of the officer under report and then give their assessment. In case of disagreement, the Countersigning Officers should give specific reasons. Similarly, if the Countersigning Officers differ with the grading or remarks given by the Reporting Officer.
- x. The Countersigning Officers should underline, in red ink, remarks which in their opinion are adverse and should be communicated to the officer reported upon. All adverse remarks whether remediable or irremediable should be communicated to the officer underreport, with a copy of communication placed in the CR dossier. Reporting Officers should ensure that proper counseling is given to the officer under report before adverse remarks are recorded.
- xi. In case of disagreement with the assessment done by the Reporting Officer, specific reasons should be recorded by the Countersigning Officers.
- xii. The Reporting and Countersigning Officers should be clear, direct, objective and unambiguous in their remarks.
- xiii. Vague impressions based on inadequate knowledge or isolated incidents should be avoided.
