NOTIFICATION

NO.SOJI/8-1(20)2017(Muharram): WHEREAS, in view of the ensuing Ashura days MUHARAM-UL-HARAM 2023, it has been suggested to impose complete ban under section 144 Cr.PC throughout the province of Sindh on the following acts from 1st Muharram-Ul-Harram 1445 Hijri, 2023 for the maintenance of law and order situation:

- 1) Carrying of all types of Arms/ Ammunition (except uniform staff Police / Rangers / L.E.As.
- 2) Misuse of Loudspeakers.
- 3) Objectionable, provocative wall chalking, posters, banners, leaflets etc
- 4) Playing of audio / video cassettes one public / Makan.
- 5) Playing Cable transmission, V.C.Rs at Hotels & Public Places.
- 6) Presence of any person on roof-toops during mourning procession.
- 7) New mourning procession / rallies / Majalis / Jalsa without permit.
- 8) Assemblage of five persons except Muharram processions / Majalis / Tazia
- 9) Double / Pillion Riding riding upon motor cyle (only 9th and 10th Muharram).

AND WHEREAS, the Government of Sindh is satisfied that in order to maintain law and order throughout the province of Sindh and to avoid any untoward incident / mishap, it is necessary to take immediate measures.

NOW THEREFORE, the Government of Sindh, in exercise of the powers conferred under Section 144 (6) Cr.P.C, do hereby impose complete ban on the acts as mentioned in above para (1) throughout the province of Sindh, provided that the ban on pillion ridding shall be for 9th & 10th Muharram only and the same shall not be applicable on the women, children below the age of 12 years, senior citizens, disabled persons, Journalists, personnel of law enforcement agencies/security agencies in uniform and employecs of essential services all over province of Sindh.

Further, all permissions issued by the Home Department, Sindh to carry weapon in relaxation of ban u/s 144 Cr.PC will remain suspended during the above said ban period.

The S.H.Os of concerned Police Stations are hereby authorized to register the complaints under Section 188 PPC in writing for the violation of Section 144 Cr.P.C against the violators of this Notification.

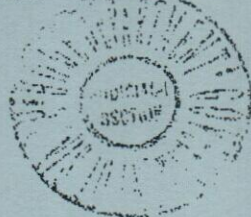
